#### REHRIWALLAS ROUNDED UP IN NEW DELHI

\*186. SHRI N. C. SEKHAR: Will the Minister for HEALTH be pleased to state:

(a) how many rehriwallas were rounded up by the New Delhi Municipal Committee during the last year;

(b) how many of them were fined; and

(c) what is the total amount of fines recovered from them during the same period?

THE MINISTER FOR HEALTH (RAJKUMARI AMRIT KAUR):

(a) 215.

(b) None.

(c) Does not arise.

SHRI N. C. SEKHAR: Is the Government aware of the fact that rehriwallas are not allowed to stand at a particular place to sell their goods? They have to move all the time and because of this they are not able to sell their goods.

RAJKUMARI AMRIT KAUR: The rehriwalla never does want to stand at any particular place. Rehriwalla means a man who circulates his goods.

SHRI N. C. SEKHAR: I have seen with my own eyes many of them in front of our house in Windsor Place being harassed every day by

the municipal authorities. Because of that they have to run about without selling their goods.

RAJKUMARI AMRIT KAUR: Sir, rehriwallas are a perfect nuisance. They interfere with health and sell food which is not commensurate with the health laws. They must be dealt with.

SHRI N. C. SEKHAR: Does the Minister know the fact that the bulk of the rehriwallas are refugees who have no place of their own and who depend on this hawking for their livelihood?

RAJKUMARI AMRIT KAUR: But, it is not a prerogative of displaced persons to break the law.

SHRI R. U. AGNIBHOJ: Sir, I want to know what are these rehriwallas.

(No reply)

SHRI S. N. MAZUMDAR: From the answer it appears that so many rehriwallas were rounded up, but they were not fined. May I take it from this, Sir, that there was no cause for convicting them?

RAJKUMARI AMRIT KAUR: Sir, as a matter of fact most of them were let off with a warning only. Then some of them were released after recovering the cost of their removal which it is within the law to do. Therefore, they were punished up to an extent.

SHRI S. N. MAZUMDAR: May I know, Sir, whether the rehriwallas have placed any demands before the Government and whether the Government has considered this problem—how to allow these people their means of livelihood, at the same time see that unhealthy articles are not sold?

MR. CHAIRMAN: Have they made any representations to you?

RAJKUMARI AMRIT KAUR: No, Sir. Representations naturally are

made to the local body concerned and they are not to give them any particular place. They always want to wander about where they wish.

SHRI S. N. MAZUMDAR: Sir, my second question was whether the Government has considered this problem in the light of allowing these people a means of livelihood, at the same time seeing that no unhealthy food articles are sold.

RAJKUMARI AMRIT KAUR: Sir, specific regulations have been made for them. They are hauled up only when they break the law.

SHRI B. K. MUKERJEE: May I know, Sir, if arrest of these 215 rehriwallas has stopped their business? And, if not, what steps do Government contemplate taking to stop it?

RAJKUMARI AMRIT KAUR: Well, Government continue to do all it can in its power to stop people from breaking the law.

सरदार रघवीर सिंह पंजहजारी : क्या सरकार को मालूम है कि रंहड़ी वाले ज्यादा रंपयुजीज हैं और अगर उनको हटाया जाय तो उनके लिये दुकानों एलाट की जाय ?

राजकुमारी अमृत कौर : मैंने आपसे पहले ही कहा है कि अगर वे शरणार्थी हैं तो इसके यह मान नहीं है कि शरणार्थियों को कोई खास अधिकार है कि वे कानून को भंग करें ।

सरदार रघवीर सिंह पंजहजारी : क्या सरकार उनके लिये किसी काम की या दुकान वगैरह देने की व्यवस्था करने को तैयार है ?

राजकुमारी अमृत कौर : आप जानते हैं कि उनके लिये बहुत कुछ किया गया है ।

सरदार रघवीर सिंह पंजहजारी : रंहड़ी वाले रंहड़ी पर ही अपना गुजारा करते हैं । अगर उनसे यह काम छीना जाय तो क्या सरकार दुकानों और स्टाल उनके नाम एलाट करेगी ?

राजकुमारी अमृत कौर : यह सवाल आप रिहॉबीलिटेशन मिनिसट्री से करें ।

SHRI N. C. SEKHAR: Does the Minister know that the things confiscated from these rehriwallas by the municipal authorities are not taken care of and consequently those things are ruined leaving these rehriwallas to undergo a great loss by which they cannot carry on their livelihood?

RAJKUMARI AMRIT KAUR: I think, Sir, that question should be put to the Home Ministry.

SHRI R. U. AGNIBHOJ: How do the rehriwallas affect the health of the people?

RAJKUMARI AMRIT KAUR: By selling food which is not fit for consumption.

SHRI N. C. SEKHAR: How do the cigarette vendors affect the health of the people?

MR. CHAIRMAN: Apart from food poisoning there is such a thing as mental poisoning also.

#### DEVELOPMENT OF TOURIST CENTRES

♦187. SHRI S. N. DWIVEDY: Will the Minister for TRANSPORT be pleased to state:

(a) whether it is a fact that a 4-crore-rupee short term plan for the development of 40 tourist centres all over the country was drawn up at a conference of State representatives and the Union Ministries concerned held in New Delhi in December 1954; and

(b) if so, what steps Government are going to take to implement the plan?

THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) and (b). A survey of the improvements needed at about 80 places of tourist importance was undertaken and a plan for

the development of these centres is under consideration and expected to be finalised soon.

SHRI S. N. DWIVEDY: Is there any short-term plan and a long-term plan for developing these centres, or is there only one plan?

SHRI O. V. ALAGESAN: The first phase of development of these places may be called the short-term plan and we want to have another plan which would include more places.

SHRI S. N. DWIVEDY: May I know, Sir, whether in this short-term plan Konarak in Orissa is included as a tourist centre for the development of the tourist centres?

SHRI O. V. ALAGESAN: Konarak is a very famous place and it has been included.

#### CENTRAL HEALTH BUREAU

♦188. SHRI S. N. DWIVEDY: Will the Minister for HEALTH be pleased to state:

(a) whether Government propose to set up a Central Health Bureau to issue pamphlets and leaflets to make the people conscious as to how to keep fit; and

(b) if so, when the Bureau is likely to be set up?

THE MINISTER FOR HEALTH (RAJKUMARI AMRIT KAUR): (a) Yes.

(b) The Bureau is expected to start functioning by the end of 1955.

SHRI S. N. DWIVEDY: Is the purpose of this Bureau only to publish these pamphlets and leaflets?

RAJKUMARI AMRIT KAUR: No. We have many aims in view, for instance, the production of film strips and health films, production of posters, preparation of models, preparation of
