Shri T. V. KAMALASWAMY: Would it be correct to say that the post was created on Rs. 1,500 but when they could not find a place on Rs. 3,000 for a man who was not wanted or against whom there are charges pending, he was shunted to this place?

MR. CHAIRMAN: All that is insinuation. I cannot allow that.

SHRI S. MAHANTY: I have got another question to ask, Sir. Was the post ever advertised?

SHRI O. V. ALAGESAN: I have no information. There was no need to advertised this post.

Mr. CHAIRMAN: Say that you have no information or it was not necessary to advertise.

SHRI O. V. ALAGESAN: Perhaps both may be there, Sir.

RAILWAY TRACK BETWEEN MADRAS CENTRAL AND ARKONAM

*200. SHRI T. V. KAMALASWAMY (ON BEHALF OF SHRI P. S. RAJAGOPAL NAIDU): Will the Minister for RAIL-WAYS be pleased to state:

- (a) what is the age of the railway track between Madras Central and Arkonam; and
- (b) whether Government have any scheme to renew the track?

THE DEPUTY MINISTER FOR RAIL-WAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) The age of the railway track between Madras and Arkonam varies from 29 to 32 years for a length of 36 miles and from 14 to 19 years for the remaining 6½ miles.

Between Vyasarpady and Villivakkam, a length of 4 miles, there is a pair of slow lines for the use of the local train service. The age of this track varies from 26 to 28 years.

(b) It is proposed to relay 6 miles.
