of 2-1/4 per cent, per annum on the issued share capital of Rs. 5 crores of the Industrial Finance Corporation. This is a contingent liability and in pursuance of it, the Central Government has made available to the Corporation a sum of Rs. 30,95,490-2-6 in respect of the last six years to make up the minimum dividend at the guaranteed rate.

The Corporation, has not issued debentures so far. It has, however issued bonds value of Rs. 7,80,50,000 bearing interest at the rate of 3£ per cent, per annum which have been guaranteed by the Central Government under section 21 (2) of the aforesaid Act as to the repayment of principal and payment of interest. The Central Government "has, however, not been called upon by the Corporation to pay to them ,any sum on account of this guarantee.

REFUND OF EXCISE DUTY ON SALT

- (a) the number of claims which have been taken to courts for refund of salt duty consequent on the abolition of that duty by Government in their Notification dated the 28th February, 1947; and
- (b) what is the result in each of those cases?

(b) Out of these 33 cases. 12 have been decided in favour and 12 against ^he Government; 4 were withdrawn by the parties and 5 are still pending.
