THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN) : (a) (i). A preliminary engineering survey between Ramshahi and Binnaguri is in progress.

(ii) Some investigation has been carried out and is being further pursued.

(b) A decision on the Ramshahi-Binnaguri alignment will be taken only after the survey report has been received and examined.

As regards the findings and recommendation about the strengthening and extension of protective measures so far as they affect the Railway line these for the present consist of extending and strengthening guide bunds, raising railway embankments and protecting them, building protection bunds at suitable places to control the course of rivers as far as possible in the circumstances prevailing, etc. The Brahmaputra River Commission and North Bengal Flood Enquiry Committee are also studying the problem as a whole. The Railway is represented on these bodies and is working in close co-operation with them. Their recommendations are awaited

(c) Restoration works including strengthening and extension of pro tective measures, wherever necessary, and to the extent possible within the time in hand are in full swing.
