SHRI O. V. ALAGESAN: The designs have been finalised and tenders for the construction have been called for and we hope to begin the work before the year is over.

RESERVATION OF WAITING ROOMS FOR AIR CONDITIONED TRAFFIC

*650. SHRI H. C. MATHUR: Will the Minister for RAILWAYS be pleased to state:

(a) whether at some of the railway stations waiting rooms are reserved exclusively for passengers travelling by air conditioned coaches;

(b) if so, the stations at which such arrangement exists; and

DR. SHRIMATI SEETA PARMA-NAND: With reference to part (c) of the question, may I know how many of the mines in Circle III are coal mines?

SHRI ABID ALI: Circle III is the Chhindwara Circle, but with regard to the break-up of the figure, I want notice.

DR SHRIMATI SEETA PARMA-NAND: May I know what is the area covered by Circle III and how much time does it take for an inspector to reach the remotest inspection point in the circle from his headquarter at Chhindwara?

SHRI ABID ALI: As I have already said, Circle III is situated in the Chhindwara District and for further information, I would require notice.

DR SHRIMATI SEETA PARMA-NAND: How many times does an inspector inspect a mine in a year? Or rather in how many years does he inspect one mine?

SHRI ABID ALI: At present the position is not a very happy one. But we have decided to increase the number of inspectors and junior inspectors and we hope to see that every mine is inspected at least twice a year, henceforth

DR SHRIMATI SEETA PARMA-NAND Is it a fact that some mines are not inspected even once in three or four years whereas the Chief inspector of Mines has remarked that they should be inspected three or four times in a year?

SHRI ABID ALI As I have already said, at present the position is not a happy one, but we hope it will be quite satisfactory soon

DR SHRIMATI SEETA PARMA-NAND Does the hon Deputy Minister think that the increase in the inspectorate that he is contemplating would meet the requirements as laid down by the Chief Inspector of Mines inasmuch as there are nearly 3,300 mines and of these mines 800 or so are coal?

SHRI KHANDUBHAI DESAI Sır. the question of making the inspection of mines adequate has been examined and tentative proposals have been drawn up There should be at least two inspections per year of non-coal mines and third-class coal mines There should be four inspections per vear of first-class and second-class coal mines other than gassy mines, and there should be six inspections of In order to give effect gassy mines to this project, the Mining Department is being strengthened and that scheme is under consideration Before long we will be able to announce that the inspecting staff has been adequately strengthened

DR SHRIMATI SEET A PARMA-NAND Are there any written instructions laid down for the inspection of mines and do these inspections include the inspection of the safety requirements? Do they form part of the regulations?

SHRI ABID ALI I think those regulations are already there

STRIKE BY THE LABOURERS IN THE LANJIBERNA QUARRY IN ORISSA

*625 SHRI S MAHANTY Will the Minister for Labour be pleased to state (a) whether the labourers employed in the Lanjiberna Quarry in the Sundergarh District went on a strike during the month of February last:

(b) if so, what were the demands of the labourers, and

(c) how the strike was settled and the disputes resolved?

THE DEPUTY MINISTER FOR ABOUR (SHRI ABID ALI). (a) The orkers were on strike from the 11th to 26th January 1955 No strike took place during February 1955

(b) The demands related mainly to reinstatement of 50 workers rendered unemployed as a result of the termination of the contract of a contractor by the management in December 1954, increase in wages, dearness allowance and bonus

(c) At the intervention of the Conciliation Officer (Central), Asansol, an agreement was reached and the workers called off the strike on the 26th January 1955 The management agreed

(1) to absorb about 50 workers employed by the ex-contractor and to make some *ex gratia* payment to them in respect of the period they remained out of employment,

(11) to enter into negotiation with the union regarding other demands; and

(111) not to victimise workers for participation in the strike and to consider some payment for the strike period which would be treated as leave without pay

SHRI S MAHANTY Sir, it appears that the services of one contractor were terminated as a result of which 50 workers had been thrown out of employment May I know, Sir, if there are any more contractors in the Lanjiberna Quarry?

SHRI ABID ALI SIr, I require notice
