SHRI ABID ALI: Sir, there are some other experts also in connection with the TWI and productivity.

MR. CHAIRMAN: But this question is about ILO, International Labour Organisation.

SHRI S. MAHANTY: Then may I know, Sir, how many experts are there solving the unemployment problem in India?

SHRI ABID ALI: Solving 1he unemployment problem?

SHRI S. MAHANTY: Yes.

SHRI ABID ALI: The hon. Member himself is one of them.

SHRI S. MAHANTY: But how many experts are there? I am no expert.

MR. CHAIRMAN: The question is about the ILO; then you spread it on to experts and so on. It is not fair.

DELHI-MADRAS JANATA EXPRESS

*712. SHRI A. S. RAJU: Will the Minister for RAILWAYS be pleased to state whether Government propose to convert the present tri-weekly Delhi-Madras Janata Express train into a daily train and if not why not?

THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN) : Not at present, due to nonavailability of coaching stock and locomotives required for the purpose.

SHRI T. S. PATTABIRAMAN: As there is a large exodus to South India during the months of April and May, at least during these months there should be special trains. May I know what action has been taken by Government in this respect?

SHRI O. V. ALAGESAN: The hon. Member and several other Members coming from the South made an oral representation to me and in accordance with that we made arrangements to have one extra bogey attached to the Grand Trunk Express. But my information is that it was not very well occupied, perhaps it was due to proper publicity not being given. We are, however, arranging to give proper publicity to it and we hope things will be better soon.

SHRI T. S. PATTABIRAMAN: Is there any proposal to run Janata Express daily during the months of April and May to enable the people to move quickly?

SHRI O. V. ALAGESAN: If there is sufficient number of persons travelling, certainly that can be done; but as I have said we are at present attaching an additional bogey to the Grand Trunk Express.

THE DEPUTY MINISTER FOR HEALTH (SHRIMATI M. CHANDRA -SEKHAR) : (a) A sum of Rs. 1,43,500 has been provided for this purpose in the current year's budget.

(b) The Deputy Director General of Health Services (Public Health Engineering) who is to be the head of the Organisation is yet to be recruited through the Union Public Service Commission. The Organisation is now functioning under the Director General of Health Services who is assisted in this matter by an Adviser in Public Health Engineering, whose services have been obtained from the T.C.A.

(c) The qualifications required of the incumbent of this post are: —

(a) a degree in Civil Engineering or an equivalent qualification with post-graduate degree or diploma in Public Health Engineering from a recognised institution; and

(b) extensive practical experience in the field of Public Health Engineering, and experience of at least five years in a responsible post in the Public Health Engineering Department or Section of a Government Corporation or major local body combined with organising ability of a high order.

DR. R. P. DUBE: How long has the gentleman from the U.S.A. been here?
