

SHRI M. VALIULLA: Is it independently of the Government of India's Commission's recommendations? They have got their own Commissions and their recommendations. Are they being implemented and are the Government of India Commission's recommendations also being implemented?

DR. K. L. SHRIMALI: As far as the Government of India are aware, they are implementing the recommendations of the Government of India Commission.

SHRI M. VALIULLA: Are they not implementing the recommendations of their own Commission?

MR. CHAIRMAN: So long as they coincide with the Central Government's recommendations.

SHRI M. VALIULLA: May I know, Sir, whether it commits the Government of India to any expense on account of the steps taken to implement their recommendations?

DR. K. L. SHRIMALI: Yes, Sir. The Government of India are giving grants to State Governments to implement the recommendations of the Secondary Education Commission.

DR. SHRIMATI SEETA PARMANAND: May I know, Sir, which are the State Governments who have set up their own Secondary Education Commissions?

DR. K. L. SHRIMALI: As far as the Government of India are aware, the following State Governments have set up their own Commissions: Uttar Pradesh, Madhya Pradesh; Bombay; Mysore and more recently West Bengal.

SHRI M. VALIULLA: Is it a condition, Sir, that only those States who implement the recommendations of the Central Government will be given the grants and not others?

DR. K. L. SHRIMALI: The Central Government will give grants for implementing the recommendations of the Secondary Education Commission of the Government of India.

SHRI M. VALIULLA: Does it mean that those States who do not carry out the recommendations of the Central Government will not get the grant?

DR. K. L. SHRIMALI: They may not get it.

THE PARLIAMENTARY SECRETARY TO THE MINISTER FOR EDUCATION (DR. K. L. SHRIMALI): (a) and (b) No, Sir.

MILITARY SCHOOL OF MUSIC AT PACHMARHI

*722. **DR. RAGHUBIR SINGH:** Will the Minister for DEFENCE be pleased to state:

(a) the details of the authorised establishment of the Military School

of Music, Pachmarhi and the sum annually provided for this school in the Budget;

(b) the details of the actual work being done by this school; and

(c) the improvements and changes proposed to be effected in the school in the near future?

THE MINISTER FOR DEFENCE (DR. K. N. KATJU): (a) Three gazetted officers and 14 non-gazetted staff.

Rs. 68,000 per annum (approximately).

(b) Hundred bandsmen of the Army are trained annually in addition to the personnel of the Navy, the Air Force and of the State Governments. Introduction of Indian music in Military bands is also being progressed.

(c) A proposal to establish a central School of music for all the three Defence Services is under consideration.

DR. RAGHUBIR SINH: Is it correct, Sir, that recently a staff artiste of A. I. R. was deputed to the school and he has made certain recommendations about a new set up for the school?

DR. K. N. KATJU: He went there, he stayed for a month, and he has made certain recommendations.

DR. R. P. DUBE: May I know, Sir, who are these experts that are considering these recommendations?

DR. K. N. KATJU: Experts who know something about this matter. I do not know, Sir.

DR. R. P. DUBE: May I know their names?

DR. K. N. KATJU: I want notice.

SHRI BHUPESH GUPTA: Do I understand that we require an expert to tell us about the experts?
