CONSTRUCTION OF THE BUILDING FOR THE NAVAL COLLEGE AT COCHIN PORT

- •317. BABU GOPINATH SINGH: V'ill the Minister for DEFENCE be pleased to state:
- (a) the cost of construction of the building for the Naval College Cochin Port;
- (b) whether any officer in Military Engineer Services had point ed out certain irregularities in the estimate of the cost of the buildings;
- (c). if so, whether any inquiry was instituted to ascertain the correct position;
- (d) if the answer to part (c) above be in the affirmative, what was the result of the inquiry; and
- (e) how the officer in the Military Engineer Services who made the allegations was dealt with by the Department?

THE DEPUTY MINISTER FOR DEFENCE (SARDAR S. S. MAJITHIA): (a) A sum of Rs. 347 lakhs has been sanctioned for the construction of Naval Training Schools at Cochin (not Naval College).

- (b) Not an officer but a Superinten dent Grade II made certain allega tions regarding the quality of work carried out at the Naval School Cons truction Project, Cochin.
- (c) Yes. An Army Court of Enquiry was convened.
