DR. K. L. SHRIMALI: We have no intention of doing that.

SHRI TAJAMUL HUSAIN: I want to know why.

MR. CH ' AN: He says that they have no intention.

DR. SHRIMATI SEETA PARMA-NAND: Is it because it is considered to be unlucky?

(No answer)

SHRI V. S. SARWATE: Is the Government aware that in the Amrita Bazar Patrika there has been some news to the effect that the Education Minister proposes to visit London for this purpose and that an agreement has already been executed?

DR. K. L. SHRIMALI: The report is unfounded.

SHRI BHUPESH GUPTA: May I know what steps have been taken by the Government for recovering the Jehangir diamond to which reference was made in this House some time ago?

DR. K. L. SHRIMALI: The Government has no intention to recover that.

SHRI T. T. KRISHNAMACHARI: I don't know—maybe private people might do things privately.

SHRI H. C. DASAPPA: May I know whether the Government are aware of any such intentions on the part of any private Arms to seek collaboration with Messrs. Mercedes Benz?

SHRI T. T. KRISHNAMACHARI: I cannot say how the Government could be concerned with intentions. I don't suppose they could unless they are criminal intentions.

SHRI B. C. GHOSE: Do I understand that the Government has no intention, apart from any arrangements they have already made with different manufacturers, to give permission to any other manufacturers to manufacture trucks or cars in India?

SHRI T. T. KRISHNAMACHARI: That would be the present intention.
