CANVASSING BY INSURANCE AGENTS

*754. SHRI J. V. K. VALLABHARAO (ON BEHALF OF SHRIMATI PARVATHI KRISHNAN): Will the Minister for DEFENCE be pleased to state:

- (a) whether it is a fact that the agents of the Indian Insurance Companies are being denied facilities for canvassing business in and around the Indian Army School in Mhow Canton ment;
- (b) whether it is also a fact that only the agents of the Prudential Life Insurance Co., are permitted to operate in that area; and
 - (c) if so, the reasons for the same?

THE MINISTER FOR DEFENCE (DR. K. N. KATJU): (a) No.

- (b) and (c). Some time ago, the Commandant of the Infantry School had ordered that only agents of such insurance companies would be allowed to operate in the School area as execute a security bond for Rs. 5,000. On review, this order has since been cancelled. Ttie r-rudential Insurance Company, which executed a bond, is now in the same position as other companies which did not execute a bond.
- SHRI J. V. K. VALLABHARAO: If the other insurance companies also execute the bond

MR. CHAIRMAN: The bond has been cancelled, and all companies are on the same level now.

DR. SHRIMATI SEETA PARMA-NAND: Does Government enquire into the political credentials of these insurance agents?

DR. K. N. KATJU: I could not quite follow the question, Sir.

MR. CHAIRMAN: What she asks is whether you enquire into the political antecedents and credentials of these companies.

DR. K. N. KATJU: The activity of the insurance companies is to insure,

and I imagine that the Commandant is very much alive to his duty.

FELLOWSHIPS OF THE LONDON UNIVERSITY INSTITUTE OF EDUCATION

(b) Fellows on return are expected to join their respective posts.

DR. K. L. SHRIMALI: A Selection Committee.
