## NATIONAL INCOME DRAWN INTO PUBLIC EXCHEQUER

- 672. DR. R. P. DUBE: Will the Minister for PLANNING be phased to state:
- (a) the proportion of the national income drawn into public exchequer

in the year before the start of the First Five Year Plan and in the third year of the Plan; and

(b) the percentage of the national income devoted to investment in the year before the start of the First Five Year Plan and in the third year of the Plan?

THE DEPUTY MINISTER FOR PLANNING (SHRI S. N. MISHRA): (a) Total revenues of the Centre and the States amounted to Rs. 765 crores in the year before the start of the First Five Year Plan, *i.e.*, in 1950-51; and to Rs. 823 crores in the third year of the Plan, i.e., in 1953-54. National Income in 1950-51 is estimated at Rs. 9,530 crores and for 1953-54 preliminary estimates place it at about Rs. 10,600 crores. Total public revenue as a proportion of national income was, thus, 8 per cent, in 1950-51 and 7-8 per cent, in 1953-54.

(b) According to an estimate made by the Taxation Enquiry Commission, total net investment in the economy amounted to Rs. 555 crores in 1950-51 and to Rs. 730 crores in 1953-54. Thus, as a proportion of national income total net investment in these two years amounted to 5-8 per cent, and 6'9 per cent, respectively.
