### NOTICE OF MOTION REGARDING RATIONALISATION MEASURES IN TEXTILE MILLS

SHRI BHUPESH GUPTA (West Bengal): Sir, I beg to give notice of a motion for the purpose of discussing a definite matter of urgent public importance—and in this I am supported by Shri Bimal Ghose and Shri Dhage—namely:—

“The serious repercussion on labour and employment situation in the country as a direct result of an intensification of rationalisation measures in textile mills as evidenced in the latest situation in Kanpur where the textile workers have declared a general strike with effect from to-day, the 2nd May 1955 and the immediate necessity for the Government of India to prohibit all manner of rationalisation or of so-called ‘intensification’ measures that increase the work-load of the workers and result in their retrenchment. In this background, the serious situation in Kanpur where hundreds of labour leaders have been arrested and the employers have taken up a far from conciliatory attitude on the question of rationalisation have to be specifically discussed in Parliament. The U. P. Government is openly supporting the employers.”

Sir, this is a matter of great importance and I think you will fix a time for the House to take up this discussion before we adjourn and the situation becomes too serious.

MR. CHAIRMAN: I will pass it on to the Labour Minister.
