### REASONS FOR SHIFTING THE INDIAN AIR FORCE ACADEMY FROM AMBALA

- •107. SHRI M. VALIULLA: Will the Minister for Defence be pleased to state:
- (a) the reasons for shifting the Indian Air Force Academy from Ambala; and
- (b) whether there is any proposal for shifting any other Indian Air Force Academy in the near future?

THE DEPUTY MINISTER FOR DEFENCE (SARDAR 9. S. MAJITHIA): (a) The reasons were as given below:

- (i) From the strategic viewpoint training establishments should as far as possible be in the interior of the country.
- (ii) the climatic conditions of the new area were considered more suitable for the type of training imparted at the Academy as the maximum flying effort could be put in throughout the year; and
- (iii) the runway at Ambala needed complete renovation which would have seriously interrupted the training programme.

SHRI M. VALIULLA: May I know, Sir, whether from the financial point of view, it is profitable to shift the establishment to Secunderabad from Ambala?

SARDAR S. S. MAJITHIA: As I said, there were more than one considera-

tions and the overall picture, after considering all of them was that 'it was better to shift this academy to Secunderabad.

#### TOBACCO DUTY COLLECTED IN UTTAR PRADESH

THE DEPUTY MINISTER FOR FINANCE (SHRI A. C. GUHA): The gross; revenue realised from the excise duty on tobacco in Uttar Pradesh during 1952-53 and 1953-54 was Rs. 4,69,17,000 and 4,84,55,000 respectively.

- SHRI S. C. KARUMBAYA: Is there any difference in the levy of excise duty on the different grades of tobacco, used for chewing and for smoking?
- SHRI A. C. GUHA: Tobacco is graded into different categories and the excise duty levied varies according to the grades.

SHRI A. C. GUHA: According to the quality of the tobacco.

श्री नवाब सिंह चौहान : क्या सरकार के पास किसानों की तरफ से ऐसी शिकायतें आई थीं कि उनके ऊपर जो असेसमेंट होता है वह गलत तरीके से होता है? क्या सरकार ने उन शिकायतों को

SHRI A. C. GUHA: There have been complaints not only from U.P. but from all the States. Recently, about a year ago, we introduced a new method in U.P. associating the village pam-chayats and the Lekhpals. That process is still under experiment. I think that method, properly worked, will remove most of the genuine grievances of the tobacco growers.

श्री नवाब सिंह चौहान: क्या सरकार ने जो सुधार किये हैं उनको किसानों तक पहुंचाने के लिए उसने कोई पब्लि-सिटी का तरीका सोचा है क्योंकि बहुत से लोग अभी तक नहीं जानते हैं?

SHRI A. C. GUHA: This is being done through the village or gaon pan-chayats. We have also arranged to distribute pamphlets in the regional language, that is Hindi so far as U.P. is concerned, and I think there won't be any difficulty in the local people knowing it. I might also add that as yet we have not been able to get the full co-operation of the Lekhpals. We are in correspondence with the U.P. Government and the Minister *in* charge of Agriculture has given us this assurance that they would see that the Lekhpals take proper interest in this matter.

PROF G. RANGA: In view of the fact that the Government is collecting so much from these tobacco growers, has anything been done to help those people to market their products either through co-operatives or through any State agency? SHRI A. C. GUHA: I think that question may be directed to some other Ministry, either Agriculture or Commerce.

PROF. G. RANGA: That is it; you only pocket the money.

SHRI A. C. GUHA: Yes, Sir, there is an exemption limit which varies from area to area according to the habits of the people. Up to that limit, the tobacco is not subjected to any excise duty.
