THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI K. CHANDRASEKHAR RAO): (a) and (b) Census conducted by the Registrar General of India, which is conducted on decadal basis, is the only authentic data in respect of population of child labour in the country. Yearly data on child labour is not available.

(c) and (d) Under the Child Labour (Prohibition & Regulation) Act, 1986, there are sufficient legal provisions available to eliminate the menace of child labour. Effective implementation of the existing law with simultaneous rehabilitative measures alongwith the convergence with the other developmental programmes is the corner stone of the strategy of the Government in the elimination of child labour.

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI K. CHANDRASEKHAR RAO): (a) State-wise and category-wise details of the number of jobseekers, all of whom are not necessarily unemployed, registered with the employment exchanges in the country as on 31st December, 2003 are given in the Statement-I. (See below)

(b) State-wise and category-wise details of the placements effected through the employment exchanges during 2000-2003 are given in Statement-II (See below)

(c) Employment exchanges function under the administrative and financial control of the respective State/UT Governments. Major activities performed by the employment exchanges are:

- Registration and Placement of Job seekers.
- Career Counseling and vocational guidance.
- Collection of Labour Market Information.

In the present employment and unemployment scenario the activities being performed by the employment exchanges are of great importance. As per the information available, the expenditure incurred on an average per employment exchange during 2001-2002, was around Rs. 14.3 lakh.
