The Embassy had not been informed about his arrival. Nevertheless they extended facility they could to him and even succeeded in getting some visas him which are normally not issued at Dr. Kumarappa short notice. gone to Europe at the apparently instance of some Peace Committee whose guest he was and who were supposed to look after him. It appears that the Peace Committee were not very successful in the arrangements they made.
