## STRENGTH OF THE DEFENCE SCIENCE ORGANISATION

- \*34. SHRI M. VALIULLA: Will the Minister for DEFENCE be pleased to state:
- (a) what is the sanctioned strength of the Defence Science Organisation; and
  - (b) what is its present strength?

THE DEPUTY MINISTER FOR DEFENCE (SARDAR S. S. MAJITHIA): (a) The sanctioned strength of the Defence Science Organisation is 267.

(b) Its present strength is 153.

SHRI M. VALIULLA: May I take it that all these people are Indians?

SARDAR S. S. MAJITHIA: I think so, Sir.

SHRI M. VALIULLA: Sir, does the Defence Science Organisation look only to the development of the defence industries?

SARDAR S. S. MAJITHIA: No, Sir; it works on problems connected with defence, ranging from ballistics, which is an item of offence in the defence, to food problems connected with defence.

SHRI M. VALIULLA: Are our people sent to foreign countries for training so that they may come and work here?

SARDAR S. S. MAJITHA: They do keep in touch with the latest developments in science.

#### FOREIGN ECONOMIC AID TO INDIA DURING 1954-55

- \*39. SHRI H. C. MATHUR: Will the Minister for FINANCE be pleased to state what economic assistance has been made available to India by foreign countries so far during the year 1954-55?
- THE DEPUTY MINISTER FOR FINANCE (SHRI M. C. SHAH): A statement is laid on the Table of the House. [See Appendix VIII, Annexure No. 3.]
- SHRI H. C. MATHUR: May I know whether these are outright grants or loans?
  - SHRI M. C. SHAH: Both, grants and loans?
- SHRI H. C. MATHUR: This statement does not give any indication as to which portion is loan and which portion is grant. Will the hon. Minister kindly make it clear?
- SHRI M. C. SHAH: The question was with regard to the assistance made available and the reply was prepared accordingly. Now when the question is asked, I say that it covers both, loans and grants. So far as the United States of America is concerned, this year there is a loan of \$ 45 million. It will carry an interest of 4 per cent, and is to be repaid within forty years.
