

INDIANS EMPLOYED BY FOREIGN FIRMS IN INDIA

(a) the number of non-Indian employees of foreign firms in India in 1947 who were drawing a salary of Rs. 1,000 p.m., and above;

(b) how many of such non-Indian employees were replaced by Indians till August 1954; and

(c) how many of these Indians who replaced the non-Indians are ex-officers of the Central Secretariat?
