DETENTION AND DESTRUCTION OF A MONKEY AT THE DUM DUM AIRPORT

- •199. SHRI S. MAHANTY: Will the Minister for HEALTH be pleased to state:
- (a) whether a monkey from Saigon bound for Paris was detained at the Dum Dum Airport and subsequently destroyed on the 16th July, 1954;
- (b) the circumstances of the arrival of the monkey at the Dum Dum Airport; and
- (c) whether any steps were taken to contact the owner of the monkey in the matter; if so, with what results?

THE MINISTER FOR HEALTH (RAJ-KUMARI AMRIT KAUH): (a) Yes.

- (b) The monkey was brought by its owner to India in contravention of the Government's quarantine regulations.
- (c) Yes. The regulations on the sub ject were brought to the notice of the owner of the monkey as well as to the Air Company concerned. The monkey was destroyed only after the Air Com pany had informed the Airport Health Officer that as there was no chance of complying with the regulations, monkey may be destroyed.

SHRI S. MAHANTY: May I know the reasons, Sir, for which the monkey was destroyed?

RAJKUMARI AMRIT KAUR: We have to be very careful that yellow fever does not come into India. That is the only reason. It is the one fever that we want to avoid if we possibly can.

SHRI S. MAHANTY: Is the Government sure that the U.S.A. chimpanzee
