SUGAR-CANE PRICES FOR 1955-56

- \*274. SHRI V. VENKATARAMANA: Will the Minister for FOOD AND AGRICULTURE be pleased to state:
- (a) whether Government fixed the price of sugar-cane for the year 1955-56; and
  - (b) if so, on what basis?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI RAFI AHMAD KIDWAI): (a) Not yet.

(b) Does not arise.

SHRI RAJAGOPAL NAIDU: long do the Government propose to take to fix the price?

SHRI RAFI AHMAD KIDWAI: The hon Member is aware that cane prices have been fixed for the coming season. Therefore, we have only to fix the cane prices for the year 1955-56. I hope, we will complete the decision by the end of October.

SHRI V. VENKATARAMANA: Is the hon. Minister aware of the fact that the factories in South India do not crush throughout the season?

SHRI RAFI AHMAD KIDWAI: I am aware of the fact that South Indian sometimes, eleven factories work, months in the year

SHRI V. VENKATARAMANA: No, no; 'full season', I mean.

SHRI RAFI AHMAD KIDWAI: factory will work full season, but I said that some of the South Indian factories worked, sometimes, eleven months in the year.

SHRI RAFI AHMAD KIDWAI: That is why I said that we would fix the price by the end of October, and the agriculturists' sowing season begin in December, January and February.

SHRI R. P. N. SINHA: Does the hon. Minister take the representatives of the agriculturists and the cultivators in confidence in fixing the price?

SHRI RAFI AHMAD KIDWAI: While fixing the price of sugarcane, I have to take into consideration the price of the alternative crops; and as the prices of alternative crops have gone down, as the hon. Member will appreciate, cane price will be lower for the next year.
