SHRI S. N. MAZUMDAR: Is it not a fact that among these people, whose number the hon. Minister gave as 73, families are also included? Is it not a fact that there are two categories of persons-one of persons who went to Andamans after 1945 and the other of persons who are there even before 1942 either as convicts or as the progeny of the convicts and who had settled there and had not even come to Calcutta or Madras throughout the whole period of their stay in Andamans?

DR. K. N. KATJU: If there are people of the category which my hon. friend has just mentioned, they will not be required to take out anything and they will be treated as Indians.

NBW POSTS IN THE EDUCATION MINISTRY FOR THE FIVE YEAR PLAN

*306. Shri GOVINDA REDDY: Will the Minister for EDUCATION be pleased to state;

- (a) whether any new posts have been created in the Ministry of Education for the implementation of the projects under the Five Year Plan;
- (b) if so, the particulars of the posts so created; and
 - (c) the number of such posts filled so far?

THE PARLIAMENTARY SECRETARY TO THE MINISTER FOR EDUCATION (DH. K. L. SHRIMALI): (a) Yes Sir.

(b) and (c). A statement is laid on the Table of the House. [See Appendix VIII, Annexure No. IOI.]

SHRI GOVINDA REDDY: May I know whether these are temporary or permanent?

DR. K. L. SHRIMALI: Temporary.

SHRI GOVINDA REDDY: May I know how these officers were recruited-whether they were recruited through the U.P.9.C. or they were directly recruited?

DR. K. L. SHRIMALI: Some were recruited through the U.P.S.C, and some were recruited from the open market and some were promoted.

SHRI GOVINDA REDDY: What Is the duration of these gazetted officers?

DR. K. L. SHRIMALI: I don't know what my hon. friend means by duration.

SHRI GOVINDA'REDDY: I wanted to know whether any definite period is fixed for these posts.

Dr. K. L. SHRIMALI: They are likely to continue for the duration of the Five Year Plan.

SHRI GOVINDA REDDY: When are the other posts going to be filled up in the gazetted ranks?

DR. K. L. SHRIMALI; They will be rilled up shortly.

SHRI GOVINDA REDDY: Are they also to be recruited from the open market?

DR. K. L. SHRIMALI: Yes, some may be.

PROF. G. RANGA: Why is it that the U.P.S.C.'s services have not been invoked in recruiting these people? Why have they recruited them directly?

DR. K. L. SHRIMALI: The reason is that it takes a long time to recruit people through the U.P.S.C. Sometimes it takes from 5 to 6 months and we needed the services of these people immediately. We appoint them on a temporary basis but always make a reference to the U,P.S.C.

PROF. G. RANGA: Is it not a fact that the Government do anticipate their need for all these additional officers and therefore they have some time and therefore they can certainly go to the U.P.S.C, always? Otherwise does it not establish a very bad precedent for Government to appointing

all these people off their own bat and afterwards present a *fait accompli* to the U.P.S.C?

DR. K. L. SHRIMALI: It is not a *fait accompli*. I have already said that we needed the services of some people immediately and therefore we recruited them and as soon as possible they are referred to the U.P.S.C, and the people are told quite clearly and definitely that they are appointed on a temporary basis.

- DR. K. L. SHRIMALI: Yes, when appointment is made reference is always made to the Commission and as soon as possible they are referred to the Commission.

SHRI GOVINDA REDDY: May I know if any new post for basic education is being contemplated?

DR. K. L. SHRIMALI: There is no special post for basic education but

Member is invited to the publication entitled "Teachers and Curricula in Secondary Schools—Report of a study by an International Team", copies of which are available in the Parliament Library. The Report forms part of the data on the basis of which proposals for the reconstruction of secondary education have been and are being worked out.
- SHRI H. C. MATHUR: What are the principal recommendations of this Committee and what principal recommendations and conclusions have been accepted by Government?
- DR. K. L. SHRIMALI: This International Team had to work within the
