THE PARLIAMENTARY SECRETARY TO THE MINISTER FOR EDUCATION (Dr. K. L. SHRIMALI): (a), (b) and (c). A statement is laid on the Table of the House [See Appendix VIII, Annexure No. 125.]

Shri B. GUPTA: I have not got the statement, but may I ask a question? Is the hon. Minister aware of certain complaints coming from various quarters that part of the money is not being spent every year although the need for this money is very great in fact?

DR. K. L. SHRIMALI: If my hon. friend had looked into the statement he would have found that most of the grants that we gave to the West Bengal Government have been utilized except in one case in 1952-53—that is item 3.

WORK DONE BY THE CHILD GUIDANCE CENTRE OPENED BY THE CENTRAL INSTITUTE OF EDUCATION, DELHI

- *444. SHRI V. S. SARWATE: Will the Minister for Education be pleased to state:
- (a) whether the Central Institute of Education, Delhi, have submitted to Government a report on the work done by the Child Guidance Centre opened in the Institute in 1952; and
- (b) if so, whether a copy of the report will be laid on the table of the House?

THE PARLIAMENTARY SECRETARY TO THE MINISTER FOR EDUCATION (Dr. K. L. SHRIMALI): (a) Yes.

(b) A copy of the report for the year 1953-54 is laid on the Table of the House. [See Appendix VIII, Annexure No. 126.]

Shri V. S. SARWATE: What is the limit of the age of the children taken in this centre?

DR. K. L. SHRIMALI: Usually young children between the ages of $2\frac{1}{2}$ to 5 or 7.

SHRI V. S. SARWATE: What is the nature of the work done in the Institute?

Dr. K. L. SHRIMALI: The Institutegets all kinds of problem children who are mal-adjusted emotionally or mentally for advice and guidance.

Mr. CHAIRMAN: Are not all maladjusted emotionally?

SHRI V. S. SARWATE: Was Mr. Caughley of the UNESCO invited to this Centre for help?

Dr. K. L. SHRIMALI: Yes, that is so.

SHRI V. S. SARWATE: What was the result of his visit?

Dr. K. L. SHRIMALI: He came to organize the Child Guidance Centre but we have not been able to carry on the work on account of lack of adequate staff in the Institute.

SHRI V. S. SARWATE: Is the Government giving them the necessary and adequate staff?

Dr. K. L. SHRIMALI Yes, that is under the consideration of the Government.

Shri V. S. SARWATE: Do Government know that because of lack of help which the Delhi School of Social Work used to give in contacting parents the Centre is suffering much in its efficiency?

DR. K. L. SHRIMALI: I cannot follow the question.

THE DEPUTY MINISTER FOR NATURAL RESOURCES AND SCIENTIFIC RESEARCH (SHRI K D MALAVIYA): (a) and (b) Yes, Sir.

(c) The examination has shown the sandstone is soft and friable near the surface and may be utilised in the manufacture of glass. The harder sand stone underlying the soft material may also be used provided the expenses incurred in crushing the rock is within the economic limit.
