

HEAD-HUNTING AMONG THE NAGA TRIBES

211. SHRI M. VALIULLA: Will the Minister for HOME AFFAIRS be pleased to state:

(a) whether head-hunting is still going on among the Naga tribes; and

(b) when the head-hunting occurred last in Indian territory?

THE MINISTER FOR HOME AFFAIRS AND STATES (DR. K. N. KATJU): (a) and (b). The information is being collected and will be laid on the Table of the House, when received.

MINTS IN INDIA

212. SHRI M. VALIULLA: Will the Minister for FINANCE be pleased to state:

(a) the installed capacity of the mints in India; and

(b) the number of coins turned out by each of these mints per day?

THE DEPUTY MINISTER FOR FINANCE (SHRI A. C. GUHA): (a) The installed capacity of the three India Government Mints at Bombay, Alipore (Calcutta) and Hyderabad is 10 lakhs, 12 lakhs and 3 lakhs pieces per day, respectively.

(b) The number of coins turned out by each of these mints on the average per day in August 1954 is

- (i) Bombay Mint . . 4.5 lakh pieces
- (ii) Alipore Mint ... 4.6 lakh pieces
- (iii) Hyderabad Mint ... 16,000 pieces

EXPENDITURE ON GOVERNMENT IMPORTS

THE DEPUTY MINISTER FOR FINANCE (SHRI M. C. SHAH) (i) and (ii) From 1948 up to the end of 1953 Government imports of "capital goods" amounted to Rs 155 crores and of "consumer goods (inclusive of food)" to Rs 10,32 crores. Earlier figures for the period August to December 1947 are not available. These figures are necessarily approximate, as there is as yet no accepted definition of the terms "capital goods" and "consumer goods"

(iii) Presumably the Member has in mind the amount spent by Government on the employment of foreign technicians. If so, these figures are being collected
