- SHRI T. S. PATTABIRAMAN: May I know whether any observers are going to be sent and if so the names of the observers?
- SHRI D. P. KARMARKAR: The gues, tion of sending one or more observers is still under consideration. It is likely that one Member of this House may be sent as an observer
- SHRI V. K. DHAGE: May I know what are the terms of this conference? Is there anything with regard to the organisation of a World Trade Organisation?
- SHRI D. P. KARMARKAR: The General Agreement on Tariffs and Trade is regarding multilateral agreements for the reduction of tariffs. There was such a conference in 1947-43 the result of which Was this GATT Organisation. A general review of the work during the last six years is to be undertaken during the coming session of the Conference.
- SHRI B. GUPTA: May I know if the Fiscal Commission has made any observations with regard to GATT and if so what are the observations made in their Report?
- SHRI D. P. KARMARKAR: I think both of us together will read the Report of the Fiscal Commission.
- SHRI B. C. GHOSE: Have the Government formulated any proposals of their own to be put before this Conference?
- SHRI D. P. KARMARKAR: This Conference deals with rather important matters and they are under the consideration of the Government at the present moment. It would be premature for us to give any detailed statement regarding any matter finalised or to j bo finalised.

- SHRI B. C. GHOSE: Does not the hon. Minister think that if any changes are to be made in the tariff policy or fiscal policy of the country, they should be placed before Parliament first in order to ascertain its opinion?
- SHRI D. P. KARMARKAR: In this matter the Government tried to ascertain the opinion of commercial bodies like the Federation of Chambers of Commerce, etc. and any views of Members of Parliament who are interested in it are welcome.
- SHRI B. C. GHOSE: Apart from the Federation, has the opinion of the consumers and other affected bodies been also elicited?
- SHRI D. P. KARMARKAR: It is very difficult to consult everybody— consumers and others. The whole question is open and anyone is welcome to send any suggestion to the Government and I can assure the hon. Member that the Government will carefully consider all such suggestion.
- SHRI B. GUPTA: The Fiscal Commission has said in its Report that the Agreement operates to the detriment of Indian interests and very strong comments have Leen made with regard to that. I want to know what steps the Government are taking to act on the basis of those observations.
- SHRI D. P. KARMARKAR: I must varify what the hon. Member says because my memory does not justify the statement that my hon. friend made just now that the Fiscal Commission has said that GATT has worked to the detriment of the country taken as a whole.
- SHRI B C. GHOSE: Is it true that the Government are trying to raise tariff and liberalise quantitative controls?
- SHRI D. P. KARMARKAR: There is a Bill introduced in the Lok Sabha.
