FARES CHARGED BY THE SCINDIA STATE RAILWAY

†254. SHRI KRISHNAKANT VYAS: Will the Minister for RAILWAYS be pleased to state:

- (a) whether it is a fact that the rates of railway fares charged from the passengers by the Scindia State Railway are higher than those charged by the other railways; and
- (b) if so, what are the reasons therefor?

THE DEPUTY MINISTER FOR RAIL-WAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) Standard passenger fares as on other Indian Railways are levied on Scindia State Section of the Central Railway. On Gwalior-Shivpuri, Gwalior-Sheopur-Kalan and Ujjain-Agar sections of this Railway, the passenger fares are, however, calculated on an inflated distance of 1½ times the actual mileage.

(b) The inflation of mileage for charge is due to high cost of operation on these sections.

EXTENSION OF TELEPHONE FACILITIES FOR INDORE

(b) This equipment is scheduled to be supplied in March 1955 and expected to be put into service by the end of 1955. In the meantime, a proposal to instal a manual exchange as a temporary measure is under investigation and, if found technically feasible, will be installed by the beginning: of next year.
