\*504. SHRI LAVJI LAKHATWSHI: Will the Minister for COMMUNICATIONS be pleased to state:

- (a) whether Government have received representation from the Government of Kutch or from any other source requesting them to connect the Kutch border with Bhuj by telephone and telegraph connections; and
- (b) if so, what action Government propose to take in the matter?

THE DEPUTY MINISTER FOR COMMUNICATIONS (SHRI RAJ BAHADUR):
(a) Yes. A desire was expressed by the Kutch Government for connecting some border towns by telegraph.

(b) Public call offices have been opened at Anjar and Mandvi. A telegraph office is sanctioned to be opened art Nakhtarana.

SHRI LAVJI LAKHAMSHI: May I know, Sir, when the other parts on this border will be connected?

SHRI RAJ BAHADUR: We have met the requirements of the Kutch Government. We have connected the two or three places that they wanted to be connected. For example Nallia and Bhachau have been connected recently and the work in connection with Nakhtarana is under way.

SHRI LAVJI LAKHAMSHI: But my question was with regard to this border which has an area of about 3,000 sq. miles with a population of over two lakhs and the proposals here concern only one point. Is there any proposal to have other points also connected?

SHRI RAJ BAHADUR: Which particular points does the hon. Member refer to?

MR. DEPUTY-CHAIRMAN: Which particular points has the hon. Member in mind?

SHRI LAVJI LAKHAMSHI: For instance, Khawda and Bella?

SHRI RAJ BAHADUR: The Khawda and Bella connection was examined but it was either not found to be practicable or remunerative.

SHRI LAV JI LAKHAMSHI: Is it not a fact that constantly this area is the victim of raids and dacoities from "Pakistan?

SHRI RAJ BAHADUR: For that purpose there are ample arrangements communication.
