INDIAN TRADE DELEGATION ON TOBACCO

*37. SHRI K. SURYANARAYANA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:

(a) whether it is a fact that Government have sent a delegation to some foreign countries to find out markets for Indian tobacco; and

(b) if so, what is the personnel of the delegation and which are the countries to be visited by the delegation?

THE MINISTER FOR COMMERCE (SHRI D. P. KARMARKAR): (a) Yes, Sir. The delegation has since returned.

The countries visited by the delegation were Japan, China, Thailand, Hongkong and Singapore.

INDIANS IN DUTCH INDIES

8. SHRI M. VALIULLA: Will the PRIME MINISTER be pleased to state the number of Indians or persons of Indian origin settled in—

- (i) the Dutch West Indies, and
- (ii) the former Dutch East Indies?

THE PRIME MINISTER AND MINISTER FOR EXTERNAL AFFAIRS AND DEFENCE (SHRI JAWAHARLAL NEHRU): Dutch West Indies comprises of Surinam (Dutch Guiana) and the Netherlands Antilles, a group of six islands, viz. Curacao. Aruba. Bonaire, Saba, St. Eustatius and a part of St. Martin. According to recent information, the number of people of Indian origin in Surinam (Dutch Guiana) is 69,856. Regarding the group of six islands known as the Netherlands Antilles, no reliable figures about Indian settlers are available. According to official sources in Holland. Indians residing in the Antilles are between 20 and 40.

The number of Indians in Indonesia (formerly known as Dutch East Indies) is about 40,000.
