DAMAGE TO SUGAR-CANE CROPS DUE TO FLOODS

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI RATI AHMAD KIDWAI): (a) and (b). 0-.5 lakh acres of sugarcane valued at about Rs. 71-00 lakhs has been affected in Bihar by recent floods. Information in respect of U.P. is being collected and will be laid on the Table of the House.
