THE MINISTER FOR WORKS, HOUSING AND SUPPLY (SARDAR SWARAN SINGH): (a) These buildings have already been completed.

- (b) Jullundur—Rs. 1,96,500 Ahmedabad—Rs. 2,93,800
- (c) The cost of construction of the main building is Rs. 2,75,900.

- (b) Construction of all the buildings at the two Institutions has not yet been finished. It is not therefore possible yet to compare final costs with the estimates.

Bombay-The building is being constructed along Queen's Road.

(c) Offices of the Central Board of Revenue, the Supreme Court, the Min istry of Food and Agriculture and the Indian Council of Agricultural Research are proposed to be shifted to the new buildings at Delhi, while the building at Bombay is being constructed for the Income-tax Department.
