MINOR IRRIGATION WORKS IN ORISSA

59. SHRI S. PANIGRAHI: Will the Minister for FOOD AND AGRICULTURE be pleased to state the amounts sanctioned by the Government of India to Orissa Government for minor irrigation projects in that State during each of the years 1953-54 and 2054-55?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI RAFI AHMAD KIDWAI): The amounts sanctioned are Rs. 26 • 43 lakh as loan and Rs. 22 • 18 lakh as grants in 1953-54 and Rs. 55•47 lakh as loan in 1954-55.

IMPORT AND EXPORT OF SUGAR

60. SHRI M. VALIULLA: Will the Minister for FOOD AND AGRICULTURE be pleased to state:

(a) the quantity of sugar proposed to be imported into India in the year 1954-55;

(b) the names of the countries from which sugar was imported in the years 1952-53 and 1953-54, the quantity imported from each of them in those years and the rate at which it was imported; and

(c) what is the quantity of sugar exported from India during the same period and the countries to which, -and the rate at which, sugar was so exported?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI RAFI AHMAD

KIDWAI) : (a) 7-5 lakh tons (including about 60,000 tons of raw sugar to be imported by sugar factories for refining) from April to December 1954. The quantity to be imported during 1955 has not yet been fixed.

REMUNERATION PAID TO THE CHAIRMAN AND MEMBERS OF THE AIR CORPORATIONS
