ALAGESAN): (a) The annual budget provides both for locomotives ordered in previous years and those to be ordered in the budget year, to the extent that debits are expected for such Progress payments are made stock. at intervals on these orders until delivery is completed, being spread out generally over a period of about three years It is not, therefore, possible to supply accurate figures relating to complete locomotives.
