THE PARLIAMENTARY SECRETARY TO THE MINISTER FOR INFORMATION AND BROADCASTING (SHRI G. RAJAGOPALAN): (a) Yes, Sir. Rates have been fixed for hire as well as sale of individual films and hire of sets of films

(b) We have just now collected information that 5,551 prints have been sold from June 1949 to the end of March 1954.

SHRI GOVINDA REDDY: May I know whether this scheme extends to all information films or whether particular films have been prepared?

SHRI G. RAJAGOPALAN: As for sets of films, we have received one set of 9 films and we have taken 18 prints of it. As for other films they are individual films.

SHRI GOVINDA REDDY: May I know whether it is open to anybody to buy any information film or docu mentary that is prepared by the Department?

SHRI G. RAJAGOPALAN: Yes.

SHRI GOVINDA REDDY: What happened to the scheme of extending arrangements for commercial distribution?

SHRI G. RAJAGOPALAN: As far as 16 mm. film is concerned, only the public institutions social institutions take it. Really and commercial institutions do not take such films. 35 mm. film is shown in all theatres and nobody is taking it, specially for com-i purposes.

SHRI GOVINDA REDDY: May I know whether any films have been sold to foreign countries under this scheme?
