SHRI S. MAHANTY: Face value means the total price of these publications.

RAJAGOPALAN): (a) Work of the Integrated Publicity Programme for the Five Year Plan is not done State-wise nor are accounts maintained State-wise. The States conduct their own publicity campaigns to popularise the Five Year Plan.

(b) Seven documentary films have already been produced and seven more are under production.

SHRIMATI VIOLET ALVA: What steps have the Government taken for audio-visual propaganda in rural India?

SHRI G. RAJAGOPALAN: The films that we produce are sent out to the community project areas and also to the touring cinemas. They show these films.

SHRI T. S. PATTABIRAMAN: Is it a fact that the integrated publicity lacks posters and pamphlets, whenever they are in demand?

SHRI G. RAJAGOPALAN: I do not think so, Sir.

SHRI B. GUPTA: May I know, Sir, if the Government is aware that the West Bengal Government is training up a bunch of artists and litterateurs at a heavy cost for carrying on propaganda for the Five Year Plan?
