

## B. C. G. VACCINATION

114. SHRI M. VALIULLA: Will the Minister for HEALTH be pleased to state:

- (a) how many persons were—  
 (i) tuberculin tested; and  
 (ii) B.C.G. vaccinated every month from June to December 1953, in each State; and  
 (b) the amount of expenditure incurred on that account during the above period.

## PETROL AT CONCESSION RATES TO AIR CORPORATIONS AND FOREIGN AIRLINES

 (b) whether the concession is extended to the foreign airlines operating in India;  
 (c) if so, which are the foreign air lines getting petrol at concession rates; and  
 (d) what is the rate of concession given on petrol to—  
 (i) Indian Air Corporations; and  
 (ii) foreign air line companies?

THE DEPUTY MINISTER FOR COMMUNICATIONS (SHRI RAJ BAHADUR): (a), (b), (c) and (d). As far as the Government of India are aware, price charged by the oil
