†[**DR**. **P. S. DESHMUKH:** Good publicity was given and the crop was also good.]

DR. D. H. VARIAVA: What is the increase in cost for the Japanese method of cultivation?

 D_R . P. S. DESHMUKH: As I said, the cost varies, but certain good cultivators have assured me that the Japanese method in many respects is much cheaper than the ordinary and local methods.
