#### APPLICATION OF THE PAYMENT OF WAGES ACT TO MANGANESE MINES

\*529. SHRI PRASADARAO (On behalf of SHRI J. V. K. VALLABHARAO) : Will the Minister for LABOUR be pleased to state whether Government propose to extend the application of the Payment of Wages Act, 1936, to the labour in manganese mines?

THE DEPUTY MINISTER FOR LABOUR (SHRI ABID ALI) : The Act already applies to the labour employed in manganese mines.

SHRI V. P. RAO: Is the hon. Minister aware that there are still many mines where this Act is not applied?

SHRI ABID ALI: I think that it has-been applied to all the manganese mines.

MR. CHAIRMAN: Are you aware that there are some manganese mines where the Act is not actually implemented? That is what he means.

SHRI ABID ALI: If the hon. Member brings to our notice the mines where it is not being implemented, certainly we will take appropriate action.

SHRI PRASADARAO: Is it applied to all categories of labour?

SHRI ABID ALI: It is applied to such categories to which the Act can be applied.

SHRI PRASADARO: Is the Government sure that all the workers working in all the mines are really put on the muster rolls?

SHRI ABID ALI: That is another question. That cannot be covered by this question
