THE MINISTER FOR FINANCE (SHRI C. D. DESHMUKH): 3 5/16 per cent. and 3 53/80 per cent. respectively per annum.

## LOANS TO JAMMU AND KASHMIR GOVERNMENT

139. SHRI P. C. BHANJ DEO: Will the Minister for FINANCE be pleased to state:

(a) the breakup of the loans amounting to Rs. 690 lakhs given to Jammu and Kashmir Government up
to 31st March 1953 into (i) Ioans for meeting the budget deficits of that Government, and (ii) for financing its development schemes;

(b) whether the loans given for meeting the budget deficits of the Jammu and Kashmir Government are free of interest; and

(c) the average rate of interest carried by loans given for financing development scheme<sub>s</sub> of that Government?

THE DEPUTY MINISTER FOR FL-NANCE (SHRI M. C. SHAH); (a) The total of loans advanced to the Jammu and Kashmir Government for development schemes and budget deficit upto 31st March, 1953 comes to Rs. 595 55 lakhs and not Rs. 690 lakhs. The latter figure represents the amount sanctioned upto December 1953. A statement showing the required breakdown of the loans of Rs. 595.55 lakhs is placed on the Table of the House. [See Appendix VII, Annexure No. 95.1

(b) No, Sir. The rates of interest being charged are given in the statement referred to in (a) above.

(c) The rate of interest for the loans given by Government of India to State Governments, etc., is specifically fixed with reference to the condition of money market at the time of sanction of the loan and the period of its repayment. The rates fixed for development loans advanced to the Jammu and Kashmir Government ' are as follows:—

> 3<sup>1</sup>/<sub>2</sub> per cent. per annum in regard to the loans advanced in the **year 1951-52 and 4 per cent. per** annum to those advanced in the year 1952-53.
