- (a) whether all the police officers employed in Delhi and New Delhi police stations to take down reports know Hindi; and
- (b) if not, what steps Government propose to take to teach them to read and write Hindi?]

THE DEPUTY MINISTER FOR HOME AFFAIRS (SHRI B. N. DATAR); (a) Some of the officers know Hindi, while others know Urdu.

(b) Arrangements have been made to teach Hindi to those who do not know it with the help of men within force who are efficient in reading and writing Hindi.

SHRI B. N. DATAR: It is taken down generally in Hindi; formerly it was taken down in Urdu.

Shri B. N. DATAR: Sir, formerly here the language was Urdu; we receive officers from the Punjab, and when these officers come they know Urdu; now, gradually they are switching over to Hindi in the Nagari script.

SHRI B. N. DATAR: So far as direct appointments are concerned we insist upon Hindi. As I told the House just now, we have to receive officers from the Punjab cadre. When they come they know Urdu and now they are made to learn Hindi.

†[Shri T. PANDE: Will Government make arrangements to take officers from the Hindi knowing States particularly?]

SHRI B. N. DATAR: That can't be done.

SHRI P. SUNDARAYYA: Why do not the Government recruit, for the jobs in Delhi, people from different States, say, a certain proportion of officers whether they know Hindi or not?

SHRI B. N. DATAR: This is a case of officers who are required for Delhi State Police, and it has been the practice here—which has been working satisfactorily—to take officers from the Punjab cadre.

Shri P. SUNDARAYYA: When you insist that only Hindi-speaking persons should be employed here and that you in the Central Government are responsible for such recruitment, will it not give the impression in the States that this is the thin end of the wedge not to have proper representation of the services from the different corners of the country?

SHRI B. N. DATAR: Sir, this is not the direct work of the Government of India. Under the Part C States Act. it is the work of the Delhi administration, and certain powers have been reserved for the Government of India and hence their concern.

SHRI P. SUNDARAYYA: Will the Government tell the champions of Hindi not to go on pressing this kind of thing on other people?
