SHRI B. C. GHOSE: Is the hon. Minister aware that* the industry produced 15 lakh tons a year or, £wo ago but the production fell during the last year?

Oral Answers

SHRI RAFI AHMAD KIDWAI: We are aware that in 1952 the production of sugar was almost 15 lakh tons but then we had a very good bumper crop of sugarcane and here I may tell the hon. Member that in Northern India, in U.P. and Bihar, the production was at the cost of the cane-producer who was paid a very low price for his cane.

THE MINISTER FOR AGRICULTURE (Dr. P. S. DESHMUKH): (a) and (b). Licences have been granted to the following three industrial undertakings for establishing new sugar factories in Madras State:

1952-53-

<i) Messrs, Tiruvannamalai Sugar Mills Ltd., Tiruvannamalai, District North Arcot.

1953-54-

- (ii) Messrs. Challapalle Sugars Ltd.. Challapalle, District Krishna.
- (iii) Messrs. Kulittalai Sugar Factory Pethaivaithalai, Ltd., Tehsil, Kulittalai, District Tiruchirapalli.
- (c) No.

SHRI P. SUNDARAYYA: We would like to know what are the places and whether they are in India or in some other country.

MR. CHAIRMAN: Tiruvannamalai is one; Challapalle is the second and Kulittalai is the third.

SHRI RAJAGOPAL NAIDU: Will the hon. Minister say what has happened to the licence that has been, granted to Tiruvannamalai Sugar Mills for the starting of a mill and whether any start has been made?

DR. P. S. DESHMUKH: I have not got the exact information.

SHRI RAJAGOPAL NAIDU: Is the hon. Minister aware of any licence being granted to Messrs. Parry & Co., for a sugar mill to be located in South, Arcot District?

DR. P. S. DESHMUKH: I have al ready given the information that the Government possesses.

SHRI RAJAGOPAL NAIDU: If the news has appeared in the local dailies, would it be

DR. P. S. DESHMUKH: - This is: somewhat hypothetical. I do not know what will be wrong and what will be right.

SHRI RAJAGOPAL NAIDU: Does the hon. Minister mean that no licence has been granted either to Parry & Co. or Ralli Brothers, both of which companies are incorporated in England?

Dr. P. S. DESHMUKH: I do not know if the hon. Member is referring: to a change of the present factory.

MR. CHAIRMAN: You say licences have been given to these three. He tells you that licence has also been granted to Par^ & Co. or Ralli Brothers which are incorporated in England but functioning in this country.

DR. P. S. DESHMUKH: There is one application under consideration—that of Messrs. East India Distilleries and

Sugar Factories Ltd., c/o Parry & Co. Ltd., but it has not been given.

SHRI B. C. GHOSE: Has any machinery been already imported against the licences that were issued?

SHRI RAFI AHMAD KIDWAI: I think one sugar factory's machinery has been transferred from East Africa to Mysore State where they are frying to build a new factory.

SHRI B. C. GHOSE: What will be the capacity of these three licences?

DR. P. S. DESHMUKH: Tiruvanna-rr.alai is 400 tons a day; Challapalle 450 to 600 tons a day and Kulittalai is 800 tons a day.

- SHRI B. C. GHOSE: What will be the annual increase in production when all these three will go into commission?
- DR. P. S. DESHMUKH: I have not got the calculation here.

SHRI H. C. DASAPPA: Are not the Government aware that there is scope for more sugar factories in the South'

SHRI RAFI **AHMAD** KIDWAI: Yes; the Government is aware and I have asked the different State Governments in the South like Mysore, Madras etc. to select sites where new factories can be set up.

SHRI H. C. DASAPPA: Is not the yield of sugarcane also very good there?

SHRI RAFI AHMAD KIDWAI: The hon. Member need not plead on the ground of advantages. We have already accepted that the South has advantages over the North in this matter.

SHRI H. C. DASAPPA: Will the Government be pleased then to encourage the starting of new factories in the South?

SHRI RAFI AHMAD KIDWAI: That is what we have been doing. I have been encouraging factories in Northern India in areas where the number of factories is larger in relation to ;he cane available, to shift to South India-

SHRI B. C. GHOSE: Will not the annual increase in production be about 14 lakh tons when these three factories go into working?

SHRI RAFI AHMAD KIDWAI: We are aiming at an additional production of 4i lakh tons.

SHRI GOPIKRISHNA VIJAIVARGIYA: Why cannot the factories in the North and South be asked to shift to Central India?

SHRI RAFI AHMAD KIDWAI: But the factories already existing in Cen tral India are not working properly.

SHRI B. C. GHOSE: Is it the Government's estimate that the probable demand would be 20 lakh tons?

SHRI RAFI AHMAD KIDWAI: As the conditions in the country improve the demand for sugar will go up five times.

SHRI B. C. GHOSE: It will be about 100 lakh tons?

SHRI RAFI AHMAD KIDWAI: The target fixed by the Planning Commission for the year 1956 has already been exceeded.

SHRI RAJAGOPAL NAIDU: Has the Government fixed any time limit within which the individuals to whom licences are granted should start functioning?

DR. P. S. DESHMUKH: We will give them reasonable time.

SHRI RAJAGOPAL NAIDU: Wha'; is 'reasonable'? How many years?

SHRI RAFI AHMAD KIDWAI: It all depends upon when he gets the machinery.

DR. D. H. VARIAVA: Has the Government any scheme¹ fh view to manufacture sugar-manufacturing machinery in India?

Dr. P. S. DESHMUKH: This question will have to be put to the Minister for Industries.

- (b) None attributable to the use of overage engines.
 - (c) Does not arise.
- (d) Yes, the points raised in the representation were:
 - (i) employment of overage locomotives;
 - (ii) reduction in the time of examination of outgoing locomotives;
 - (iii) defective fittings on locomotives; and
 - (iv) drivers having to take out defective locomotives.

SHRI S. N. MAZUMDAR: May I know whether any action has been taken on these points made out in the representation?

SHRI O. V. ALAGESAN: They are not true to facts, Sir. These things are not true, namely, reduction in the time-of examination of outgoing locomotives and so on.
