SHRIMATI MAYA DEVI CHETTRY: May I know, Sir, the total amount of the Military Service Post War Reconstruction Fund and the basis on which this amount has been divided amongst the various States in India and Nepal?

SARDAR S. S. MAJITHIA: I have not got the figures here, Sir, but so far as I remember, I think it is worked out at the rate of one rupee per recruit who is sent for colour service.

SHRIMATI MAYA DEVI CHETTRY: Is it a fact that the Gorkha Ex-Servicemen settlers in various States have been denied the benefits of the local Post War Reconstruction Fund?

SARDAR S. S. MAJITHIA: That did come to our notice in the case of a couple of States but that matter has been taken up with those two States and I am quite sure that that will not happen again.

SHRIMATI MAYA DEVI CHETTRY: May I know, Sir, the names of the States and the reasons for denying such benefits to the Gorkha Ex-Servicemen only?

SARDAR S. S. MAJITHIA: Sir, this happened as a result of a mis-understanding, or, you may call it a misinterpretation of rules; they are being brought to the notice of the States and, as I said, I am quite sure that they will fall in line with the general rules and that these Gorkhas will not be debarred from getting the benefits.

SHRIMATI MAYA DEVI CHETTRY: Is it a fact, Sir, that the sum of rupees ten lakhs released from Nepal's share in the Post War Reconstruction Fund is an additional allotment for these Gorkha Ex-Servicemen's welfare fund?

S. MAJITHIA: Un-SARDAR S fortunately the hon. Member is referring to a question which is being dealt with by the Ministry of External Affairs. Our relations with Nepal are governed by that Ministry.

SHRIMATI VIOLET ALVA there no liaison officers to keep up the contact between these Gorkha Ex-Servicemen and the Government?

SARDAR S S. MAJITHIA: No, there are no liaison officers, and what is more, they are not needed because we have got the Soldiers', Sailors' and Airmen's Service Board which is already looking after their interests.

†[DR. K. L. SHRIMALI: I wish to tell the hon. Member that our universities are autonomous bodies and we do not formulate rules for their courses of study, etc.]

It will have to be decided upon by the universities themselves because the universities are autonomous bodies and they prescribe their own courses of study.]

†[Dr. K. L. SHRIMALI: I do not have information regarding all universities, but so far as I know. some universities have taken steps in this direction. Besides the Banaras Hindu University, probably, Nagpur has also adopted the Hindi medium up to the B.A. stage. There are some more universities as well, but I do not have full information about them with me.]

†[Shri D. NARAYAN: May I ask what difficulties are experienced by the universities in this connection?]

†[Dr. K. L. SHRIMALI: I wish to inform the hon. Member that all the central universities are, to a greater or smaller extent, taking steps in this direction. The Aligarh University has not yet made Hindi as the medium,

but it has made Hindi a compulsory subject for all undergraduate students. Similarly, in the Delhi University as well, English is the medium of instruction, but the University Academic Council has appointed a committee which has considered how to adopt Hindi as the medium. It has also apcommittee which pointed another would translate books on science and other subjects. Similarly, all the universities are taking some steps towards making Hindi the medium of instruction. But it is a thing which cannot be hustled through.]

SHRIMALI: I have ready explained the position, Sir. far as the Central Government is concerned, it is in agreement with recommendations of the University Education Commission which had recommended that Hindi or the regional language should be the medium of instruction; but the Government has no intention of prescribing rules or courses of studies for the universities.

†[Dr. K. L. SHRIMALI: No, Sir, Government are not at all satisfied but I have stated that Government have no intention of interfering in this matter. It would be dangerous if they interfere in university matters in this way.]

Shri V. K. DHAGE: Sir, the Parliamentary Secretary said that the universities are autonomous and that the central universities would follow their own courses. Am I to understand that this will be the thing followed with regard to the universities that are to be taken over by the Centre hereafter?

Dr. K. L. SHRIMALI: The central universities as well as the other universities are autonomous bodies and they have the freedom to prescribe courses of studies. Government have no intention of interfering with the courses.

Shri P. V. KANE: Will the hon. Minister tell us the total number of books in the library?

DR. K. L. SHRIMALI: The total number of books and periodicals in stock in the library on the 28th February, 1954, was 40,175.

SHRI P. V. KANE: May I know the budget amounts for these three years?

DR. K. L. SHRIMALI: Every year we make a provision of Rs. 5,000, but as the hon. Member would see, we have been able to spend little more than the budget provision.

Shri P. V. KANE: I am asking the total budget for the whole of the Archæological Department.

Dr. K. L. SHRIMALI: I cannot give just now the figures for the whole department.

Shri P. V. KANE: Will the Government see that the present Archæological Library is housed in a better place? I am going there on so many days and I find there is no proper provision for sitting.

Dr. K. L. SHRIMALI: We are now short of accommodation and as soon as the position improves we will try to provide better accommodation for the Library.

Shri R. P. N. SINHA: Is it also its function to secure manuscripts of valuable old books against payment?

Dr. K. L. SHRIMALI: Yes, Sir, whenever a new manuscript comes to the notice of the Government we do acquire that manuscript.
