(b) The official concerned lodged a protest with the appropriate authorities in Hanoi who regretted the incident.

### STOCK OF PIT-HEAD C3AL

\*659. SHRI B C. GHOSE: Will the Minister for PRODUCTION be pleased to state:

(a) the grade-wise stock of pit-head coal in Bengal and Bihar coal-fields at the end of each year from 1948 to 1953; and

THE MINISTER FOR PRODUCTION (SHRI K. C. REDDY): (a) A statement is laid on the Table of the Council. *[See* Appendix VII, Annexure No. 300.]

(b) Wagon quota is fixed for different industries and not for different grades of coal. As slack coal is mostly used for brick burning purposes and colliery quotas have been fixed for BRK Class, it is presumed that the hon. Member is referring to the wagon quota for brick burning coal. The present monthly BRK quota for collieries in Bengal/Bihar fields is 0,378 wagons which could move a quantity of approximately 21 lakh tons of slack coal.

### AGRICULTURAL LAND FOR DISPLACED PERSONS

(a) the total area of agricultural land left by non-Punjabi displaced persons in West Pakistan;

(b) The area of evacuee agricultural land in India is about 10 to 12 lakh acres, including lands held by non-evacuee tenants.

(c) No target date has been fixed.
