DR. P. S. DESHMUKH: Yes, whenever conditions warrant; and whenever we think that without controls the situation is likely to be very much worse, we have no hesitation to control. We are not disliking controls as such.

SHRI GOVINDA REDDY: I want to know whether at any time the prices of chillies and oil were con trolled? To say that Government burnt their fingers is.....

Dr. P. S. DESHMUKH: I did not mean chillies in particular.

SHRI K. S. HEGDE: Is it not a fact that the Government considers controls as a necessary

DR. P. S. DESHMUKH: Yes, to that extent we do.

DR. SHRIMATI SEETA PARMANAND: To us who do not use chillies, because we have so many other things for savoury, the importance of chillies might look rather trivial; but for the poor, we will all agree, there is no other spice which can make their food savoury. So if the Government cannot control the price of chillies, they should at least open co-operative shops for some of the essential necessities of food like chillies and oil and should invite the people to take shares. Instead of waiting for the people themselves to start these shops, will the Government themselves open these shops?

DR. P. S. DESHMUKH: Co-operative shops and co-operative organisations are for the people themselves to organise and not for the Government.
