## SUPPLUF OF AERATED WATER ON THE RAILWAYS

ALAGESAN): (a) The sale of aerated water at railway stations is generally undertaken by private contractors under contract with the railways, the only exception being that undertaken by the departmentally run Aerated Waters Factory at Kharagpur on the B.N. Railway portion of the Eastern Railway zone.

- (b) Prices vary in terms of the quality of aerated water supplied irrespective of whether it is manufactured in the departmentally run factory or sold by private contractors.
