

THE MINISTER FOR FINANCE (SHRI C. D. DESHMUKH) : (a), (b) and (c). -Except for a sum of Rs. 47-18 lakhs of the Railway Revenue Reserve Fund invested in loans and shares of Branch Line Companies the balances of the various Depreciation and Reserve Funds are not invested but kept with Government. As regards the Cash Balance Investment Account, the securities held on the 31st March 1947, 1952 and 1953 amounted to Rs. 61-96 crores, Rs. 47-81 crores and Rs. 64-96 crores respectively and they were all Central Government Securities.

LOWER GONDWANA ROCKS OF LISH VALLEY IN DARJEELING

STATEMENT

Results of the Examination of the Lower Gondwana Rocks of Lish Valley in Darjeeling.

An examination of the three blocks in the Himalayan foot hills situated in the Yangmakum Khasmahal lands and the Chel Reserved Forest area in Darjeeling district was undertaken by the Geological Survey of India in November 1952, with a view to find out whether mining operations in this area would affect the stability of the hill slope. The study revealed,—

(i) that mining operations could be undertaken without undue danger to the stability of the hill slope;
