SHRI O. SOBHANI: Is it a fact that an applicant's name is kept on the register for two months at a time and if in that interval he is not absorbed, his name is removed from the list?

SHRI ABID ALI: Yes, but if he chooses, he can renew the continuance of his name on the live register and he will have seniority on that basis.

BEGAM AIZAZ RASUL: May I know how many employment exchanges There are in the country"

SHRI ABID ALI: About 126.

t[SHRI ABID ALI: Recruitment is] made through the Public Service Commission. For recruitment which is not made through the Public Service Commission candidates are sent up by the Exchanges. And, as I said earlier, if we cannot give suitable men, people are got from outside.]

BEGAM AIZAZ RASUL; May I know if the applicant has to pay any fee for registering his name in the Employment Exchange?

SHRI ABID ALI: Nothing at all.

VIJAYAWADA AERODROME

*53. SHRI PRASAD ARAO: Will the Minister for COMMUNICATIONS be pleased to state whether Government propose to reopen Vijayawada Aerodrome for regular air service?

THE DEPUTY MINISTER FOR COMMUNICATIONS (Sim RAJ BAHADUR) : Experiments made in the past of operating air services to

Vijayawada showed that the traffic potential of Vijayawada was very low. The Indian Airlines Corporation who are now responsible for the operation of all internal scheduled air services examined again the possibility of bringing in Vijayawada along with a few other towns on a suitable air route, but found that such an operation would be very uneconomic.

SHRI PRASADARAO: When was the enquiry made?

SHRI RAJ BAHADUR: It was actually experimented upon and found to be not paying its way.

SHRI PRASADARAO: Does Government know that the number of air-minded people has increased recently?

SHRI RAJ BAHADUR: We may enquire again but enquiries have been made a number of times.

SHRI P. SUNDARAYYA: What is the difficulty in halting the plane that goes from Madras to Calcutta at Vijayawada when there is an aerodrome already?

SHRI RAJ BAHADUR: It was already experimented upon between Madras and Vijayawada and Hyderabad, Vijayawada and Visakhapatnam.

SHRI P. SUNDARAYYA: What is the extra cost that the Government of India will be incurring through their Airlines Corporation if the plane that flies from Madras to Calcutta halts at Vijayawada and takes off again?

SHRI RAJ BAHADUR: Every landing and taking off costs as much as Rs. 500 for each halt.

SHRI P. SUNDARAYYA: Will it not be possible—even though it may cost Rs. 500 for each take-off—to increase the postal as well as other facilities, and is it not worth while

to see that these stations are also brought into line?

SHRI RAJ BAHADUR: We take into account income from freight as well as fares and in spite of that it has not been found to be economical.

SHRI H. D. RAJAH: Will Government consider it desirable to have Vijayawada as a station and not Visakhapatnam?

MR. CHAIRMAN: That does not arise here.
