## DISCIPLINARY CASES AGAINST OFFICERS OF ALL INDIA SERVICES

\*68. SHRI S. N. DWIVEDY: Will the Minister for HOME AFFAIRS be pleased to state the number of disciplinary cases against officers belonging to the Indian Civil Service, Indian Administrative Service, Indian Police and Indian Police Service referred to the Federal or Union Public Service Commission since 1947?

THE DEPUTY MINISTER FOR HOME AFFAIRS (SHRI B. N. DATAR): 40 cases in all, made up as follows:-

SHRI S. N. DWIVEDY: How many of these have been finally decided by the Public Service Commission?

SHRI B. N. DATAR: 37 cases have been finally decided.

SHRI S. N. DWIVEDY: In how many cases did the Government not «,gree with their recommendations?

SHRI B. N. DATAR: Government accepted the recommendations of the U.P.S.C. in 35 cases.

SHRI S. N. DWIVEDY: Is it a fact that in a certain case, in the case of a certain officer of the Bombay State, the Government requested the Public Service Commission to reconsider their decision?

SHRI B. N. DATAR: Sir, that is a confidential matter, but the matter is still under consideration.

SHRI S. N. DWIVEDY: Was any officer promoted while disciplinary ae tion was going on against him?

SHRI B. N. DATAR: Not to my knowledge.

## IRON ORE IN KRISHNA DISTRICT IN ANDHRA

- \*69. SHRI PRASADARAO: Will the Minister for NATURAL RESOURCES AND SCIENTIFIC RESEARCH be pleased to state:
- (a) whether it is a fact that large deposits of iron ore are found in Krishna district in Andhra; and
- (b) whether large quantities of iron ore are being exported from this area to foreign countries?

THE DEPUTY MINISTER FOR NATU-RAL RESOURCES AND SCIENTIFIC RESEARCH (SHRI K. D. MALAVIYA): (a) No iron ore deposits of importance have been reported to Government in the Krishna district of the Andhra State.

(b) It may be that Jaige quantities of iron ore are exported from this area; but since export statistics are not maintained area-wise, the Government are unable to say wiiat the exact position is.

SHRI PRASADARAO: Is the Government looking into the newspapers?

SHRI K. D. MALAVIYA: Some persons in the Government generally do so.

PROF. G. RANGA: When this question was received by them, was it not possible for them to obtain this information from the Bezwada railway station wherefrom it is being sent?

SHRI K. D. MALAVIYA: We have not denied that exports are made from that area, but what we have said is that iron ore deposits of any magnitude have not been reported to Government in the Krishna district.

PROF. G. RANGA: To the question "whether large quantities of iron ore are being exported from this area" the answer could easily have been

given by getting the information from the Bezwada railway station. The answer given is: "it may be" etc. Was it not possible for the Government to ask for this information from the Bezwada railway station staff?

Oral Answers

SHRI K. D. MALAVIYA: Our bona fide source of information is the Minis try of Commerce and Industry and -when we made enquiries from them we were told what exactly I have given In the answer.

SHRI P. SUNDARAYYA: Is the Gov-•ernment not aware that everyday some 200 to 400 lorries take this iron ore from a place called Nandigama Taluka near Jaggayyapeta, 40 miles from Vijayawada and that it is transhipped to Bezwada and Masulipatam by rail as well as by canal?

SHRI K. D. MALAVIYA: I take this Information from the hon. Member. I •should presume that it might be true but I cannot give an actual assessment of the quantity that is exported.

SHRI P. SUNDARAYYA: As every -day 200 to 400 lorryloads (of 3 to 5 ton capacity) of iron ore are being exported during the last six months to one year, does the Ministry consider that there is iron ore of sufficient importance there?

SHRI K. D. MALAVIYA: On the Information given by the hon. Member I will make a specific enquiry about the quantity exported from that area. With regard to the natural finds of "Iron ore underground I have nothing more to add to my answer.

SHRI PRASADARAO: Will the Gov\* ernment have a survey made by experts?

SHRI K. D. MALAVIYA: We will, in due course of time.

PROF. G. RANGA: Is the Government aware that oil is also found there?

SHRI K. D. MALAVIYA: Ore? I :bave not denied it.

PROF. G. RANGA: Are Government taking any steps to ascertain whether realiy oil has been struck in that area ind, if so, what can be the possibilities?

SHRI GOVINDA REDDY: Has any new mineral survey been made in that area?

SHRI K. D. MALAVIYA: The Geological Survey of India has a programme for prospecting and explorations and in Andhra also we have got our programme.

PROF. G. RANGA: We were told the other day in reply to a question regarding prospecting for oil in West Bengal and Assam that the Government had concluded some sort of an agreement with Burmah Shell for such purpose. Can any such effort be made in regard to the prospecting for oil in other areas including this area?

SHRI K. D. MALAVIYA: I think iron ore has nothing to do with oil.
