SHRI P. C. BHANJ DEO: Are profits likely to improve with the disposal of surplus labour and departmentalisation of labour payments?

SHRI K. C. REDDY: In regard to the first part of the question, yes. With regard to the second part, it is likely that the cost of operation will increase.

SHRI B. C. GHOSE: Will the hon. Minister state any reason as to how the loss of about 60 lakhs in 1950-51 was converted into a profit of about 11 lakhs in 1951-52?

SHRI K. C. REDDY: Well, better working is one of the causes certainly. The second cause is that there was quite a lot of our burden that was removed in the earlier years and that cost of operation did not accrue in the subsequent years'. That also helped in the realisation of more profits.

SHRI B. C. GHOSE: Has the hon. Minister figures prior to 1950-51 to show for how many years losses were sustained by the State Railway Collieries?

SHRI K. C. REDDY: 1 have got the figures from 1936-37 onwards. I can give them if the hon. Member would give notice of a separate question.

SHRI B. C. GHOSE: After how many years of loss was profit earned for the first time in 1951-52 by the collieries?

SHRI K. C. REDDY: In the previous years also it was not as if we were suffering losses continuously. During some years there was profit and during some years there were losses. So I cannot give an answer to the question as it has been put by the hon. Member.

SHRI KISHEN CHAND: Is it a fact that this loss was converted into pro-Hi by a book adjustment, calculating the price of coal at a higher rate?

WINDING WIRES REQUIRED FOR POWER AND DISTRIBUTION TRANSFORMERS

- 42. SHRI M. VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:
- (a) the total quantity of winding wires required for power and distribution transformers in India;
- (b) what steps have toeen taken by Government to manufacture enough winding wires in the country; and
- (c) how long it will take to make India selfsufficient in this respect?
- THE MINISTER FOR COMMERCE (SHRI D. P. KARMARKAR): (a) The existing producers of transformers require annually approximately 700 tons of winding wires and strips, bare and insulated;
- (b) Two firms are at present manufacturing winding wires. Two more firms have been granted permission for manufacturing this item. In addition one of the existing firms has an approved scheme for expansion.
