#### EMPLOYMENT OE INDIANS BY FOREIGN CON-CERNS IN INDIA

\*498. SHRI GOVINDA REDDY (On behalf of SHRIMATI VIOLET ALVA): Will the Minister for COMMERCE AND INDUSTRY be pleased to refer to the reply given to starred question No. 275 in the Council on the 10th March, 1954 and state whether the foreign firms who had been given an extension of time up to the 15th March, 1954 have now submitted their returns?

THE MINISTER FOR COMMERCE (SHRI D. P. KARMARKAR): The time limit was further extended up to the 15th April 1954 for all firms. About 1,300 returns have been received and are being analysed.

SHRI GOVINDA REDDY: How many returns have been received since the 15th of March?

SHRI D. P. KARMARKAR: I have not the split-up of the figures. We are still receiving.

SHRI GOVINDA REDDY: What action do Government propose to take with regard to those firms who fail to supply this return?

SHRI D. P. KARMARKAR: We have not yet begun to think of that. We are considering those we have received, to see the results, and then we shall see what steps to take

SHRI B. GUPTA: Is the Government aware that some time back ths Bengal jChamber of Commerce and Industry which is an organisation of British firms in India, issued a circular to their constituents saying that these facts should not be furnished to the Government of India unless and until they had decided on the matter as to hnw the matter should be tackled?

SHRI D. P. KARMARKAR: Our info, nation on this point is that the Chamber of Commerce were in doubt

about certain points and so they wanted to discuss those matters at the highest level in our Ministry. Pending that they had advised their constituents saying that they could be sent after getting Government's instructions with reference to that information. It was a natural postponement in view of those instructions.
