SHRI S. MAHANTY: Sir, I want to put one more question.

MR. CHAIRMAN: No more questions. The report will be published; you have not read the statement also.

'U.S. TECHNICAL PERSONNEL FOR RIHAND PROJECT

*497. SHRI PRASADARAO: Will the Minister (for IRRIGATION AND POWER) be pleased to state:

(a) whether Government have entered into an agreement with the Government of the United States of America in regard to the supply of technical experts for the construction of the Riband Project; and

(b) if so, what is the number of such experts asked for?

THE DEPUTY MINISTER FOR IRRIGATION AND POWER (SHRI J. S. L. HATHI): (a) and (b). The hon. Member is presumably referring to Operational Agreement No. 20 signed on the 29th March 1954, copies of which are available in the Library of the House, under which the Government of U.S.A., will make available equipment and supplies for the construction of the Riband Dam. It also provides that, if the Government of Uttar Pradesh need the assistance of either a j construction management and en-

gineering service firm or consulting engineers or both, such selection will be made by the Uttar Pradesh Government with the concurrence of the Government of India and the Technical Co-operation Mission authorities and funds made available for the procurement of such services.

SHRI PRASADARAO: What is the nature of these experts? Are they experts in Hydrology or Geology or Electricity?

SHRI J. S. L. HATHI: The services of these experts have not yet been requisitioned by the UP. Government. What the agreement provides is that in case they want an expert, they will be provided with one. That is the only thing and nobody has yet been invited.

PROF. G RANGA: Is it a multipurpose project, Sir?

SHRI J. S. L. HATHI: It will, of course, be a multi-purpose project but for the present it is only a power project.

Low Cost HOUSING EXHIBITION

*499. SHRI P. C. BHANJ DEO: Will the Minister for Works, HOUSING AND SUPPLY be pleased to state the total expenditure incurred by Government on the Low Cost Housing Exhibition held recently?

THE MINISTER FOR WORKS, HOUSING AND SUPPLY (SARDAR SWARAN SINGH): The accounts of the Exhibition, which came

to a close on 31st March, 1954, have not yet been finalised. The total expenditure is, however, expected to be in the neighbourhood of Rs. 8.7 lakhs.

SHRI V. K. DHAGE: Is it a fact, Sir, that these houses would be given away to certain people?

SARDAR SWARAN SINGH: They will not be given away but will be retained by the Government for occupation by the trainees.

MAJ.-GEN. S. S. SOKHEY: Can I ask the hon. Minister as to what is meant by 'low-cost housing'? I can understand, in 1954, a house to provide suitable living conditions, properly

built and so on; but what is the meaning of 'low cost housing'?"

SARDAR SWARAN SINGH: Simple dictionary meaning, Sir.

MAJ.-GEN. S. S. SOKHEY: If that is the case, when is the Government going to organise 'low cost education', 'low cost this' and 'low cost that'?

MR. CHAIRMAN: Well, these are other questions.

SHRI GOVINDA REDDY: I wanted to know the number of foreign countries that participated in this Exhibition.

SARDAR SWARAN SINGH: I do not recollect the exact number but the number was quite considerable, of the order of ten or twelve.

SHRI B. GUPTA: Sir, in some of these low cost houses in the Exhibition with a cost of construction of about Rs. 3,000 to Rs. 4,000, we saw radio sets costing about a thousand rupees. What is the big idea in displaying such expensive radio sets there? Does the Minister want to show that the people occupying such houses will have such radios and will have the means to possess such radio sets?

SARDAR SWARAN SINGH: The cost of the radio was not included in the cost of the houses. Actually, we were making some money in permitting display of radio sets there and that added certain charm to the building. I am sure the hon. Member must have liked it although he is raising an objection here.

SHRI B. GUPTA: It was part of the furniture, and household equipments

SARDAR SWARAN SINGH: No, Sir, that is incorrect.

DR. P. C. MITRA: What is the cost of a low cost house, Sir?

SARDAR SWARAN SINGH: It differed from house to house and it was displayed outside the plot.

PAYMENT OF INTERIM COMPENSATION TO-DISPLACED PERSONS

*500. DR. R. P. DUBE: Will the Minister for REHABILITATION be pleased to state:

(a) what was the estimated amount expected to be paid to 50,000 high-priority claimants as interim compensation within the period of two months from November 28, 1953; and

(b) what is the amount actually paid so far and what is the number of displaced persons who have received such compensation?

THE DEPUTY MINISTER FOR REHABILITATION (SHRI J. K. BHONSLE) : (a) No such estimate was prepared.

(b) The amount paid in cash and kind to 9,349 priority claimants up to the 17th April, 1954, was Rs 1,19,83,394.

DR. R. P. DUBE: May I know the amount that was to be paid?

SHRI J. K. BHONSLE: I have said in answer to the first part that no such estimate was prepared.

PROF. N. R. MALKANI: When do you think all these claims of the five categories will be cleared? By what date approximately?

SHRI J. K. BHONSLE: It would be very difficult to say, Sir.

DR. R. P. DUBE: How many of these 50,000 claims have been paid off?

SHRI J. K. BHONSLE: 9,349.

DR. R. P. DUBE: Is it a fact that they would be paid only within the two months?

SHRI J. K. BHONSLE: No, Sir, it is not a fact that they would be paid in two months only; they have been paid all along.
