CATERING ARRANGEMENTS ON THE HOWRAH-DEI HI TRAINS

♦103. SHRI B. RATH: Will the Minister for RAILWAYS be pleased to state:

(a) when the present caterers on the trains running between Howrah and Delhi were first appointed;

(b) whether the Railway Administration calls for tenders for the appointment of caterers on these trains every year;

(c) if so, when the last tenders were called for:

(e) the reasons for which the present caterers were appointed?

The present caterers were first appointed in trains running between Howrah and Delhi as shown below: —

(i) Western style Dining Car an the Howrah-Delhi Mail.—Messrs. G. F. Kellner & Co. Ltd. have been running the contract for many years. The exact date of their first appointment is not available.

(ii) *Indian style Dining Car on Toojan Express.* Messrs. Ballabhadas Agrawal were first appointed in 1938.

SHRI B. RATH: May I know whether there is any rule that these caterers should be appointed after inviting tenders?

SHRI O. V. AL AGES AN: 1 just said that these contracts are not let out on tender basis.

MR. CHAIRMAN: He wants to know whether there is any rule requiring you to ask for tenders.

SHRI O. V. ALAGESAN: There is no such rule.

SHRI B. RATH: Is it not a fact that because of these contractors being there in the Railway for a large number of years they do not look to the comforts of the passengers and the food supplied in the dining cars is deteriorating year by year?

MR. CHAIRMAN: It is a matter of opinion.

SHRI P. SUNDARAYYA: Is it not a fact that in the Grand Trunk Express the dining car provides meals at the rate of Rs. 1/8 whereas the same meals could be had for ten annas to twelve annas on the Southern Railway?

SHRI O. V. ALAGESAN: I do not know the exact rate. But this question relates to the Eastern Railway.
