MR. CHAIRMAN: It is all right.

SHRI A. C. GUHA: The matter concerned only the Assam Government. So it was sent to the Assam Government.

STATEMENT *RE* STARRED QUESTION NO. 35. THE DEPUTY MINISTER FOR NATURAL RESOURCES AND SCIENTIFIC RESEARCH (SHRI K. D. MALA-VTYA): Sir, to a supplementary question regarding the recommendation of the Conference of Vice-Chancellors in respect of the composition of the University Grants Commission asked by Shri H. N. Kunzru in the Council of States on 25th August 1953 on Starred Question No. 35 by Shri Govinda Reddy, my reply should be corrected as follows:

"Yes, Sir. The Conference recommended that the Commission shall be composed of not more than 9 members, one third of whom shall be Vice-Chancellors of Universities and the rest eminent educationists, men of academic distinction and administrative and financial experience."
